# Instructions for use **DHEA-S ELISA**







# INTENDED USE

For the direct quantitative determination of DHEA-S by an enzyme immunoassay in human serum.

# PRINCIPLE OF THE TEST

The principle of the following enzyme immunoassay test follows the typical competitive binding scenario. Competition occurs between an unlabelled antigen (present in standards, controls and patient samples) and an enzyme-labelled antigen (conjugate) for a limited number of antibody binding sites on the microplate. The washing and decanting procedures remove unbound materials. After the washing step, the enzyme substrate is added. The enzymatic reaction is terminated by addition of the stopping solution. The absorbance is measured on a microtiter plate reader. The intensity of the colour formed is inversely proportional to the concentration of DHEA-S in the sample. A set of standards is used to plot a standard curve from which the amount of DHEA-S in patient samples and controls can be directly read.

# **CLINICAL APPLICATIONS**

Dehydroepiandrosterone sulfate (DHEA-S) is produced by the adrenals and gonads. As a result, the determination of the level of DHEA-S in serum is important in the evaluation of the functional state of these glands. DHEA-S is a precursor of testosterone and estrone. Besides the adrenals in females, the ovaries have been shown to be an important source of DHEA-S. It has been reported that there is a fluctuation day by day of DHEA-S in women during the ovulatory cycle.

The principle production of testosterone in females is from conversion of other related androgens, especially DHEA-S. An abnormal testosterone level in women should be accompanied by the estimation of serum DHEA-S. The use of serum testosterone determination in conjunction with Elisa of DHEA-S can be used to determine if the source of excess androgen production is ovarian or adrenal.

# **PROCEDURAL CAUTIONS AND WARNINGS**

- 1. Users should have a thorough understanding of this protocol for the successful use of this kit. Reliable performance will only be attained by strict and careful adherence to the instructions provided.
- 2. Control materials or serum pools should be included in every run at a high and low level for assessing the reliability of results.
- 3. When the use of water is specified for dilution or reconstitution, use deionized or distilled water.
- 4. In order to reduce exposure to potentially harmful substances, gloves should be worn when handling kit reagents and human specimens.
- 5. All kit reagents and specimens should be brought to room temperature and mixed gently but thoroughly before use. Avoid repeated freezing and thawing of reagents and specimens.
- 6. A standard curve must be established for every run.
- 7. The controls should be included in every run and fall within established confidence limits.
- 8. Improper procedural techniques, imprecise pipetting, incomplete washing as well as improper reagent storage may be indicated when assay values for the controls do not reflect established ranges.
- 9. When reading the microplate, the presence of bubbles in the wells will affect the optical densities (ODs). Carefully remove any bubbles before performing the reading step.
- 10. The substrate solution (TMB) is sensitive to light and should remain colourless if properly stored. Instability or contamination may be indicated by the development of a blue colour, in which case it should not be used.
- 11. When dispensing the substrate and stopping solution, do not use pipettes in which these liquids will come into contact with any metal parts.
- 12. To prevent contamination of reagents, use a new disposable pipette tip for dispensing each reagent, sample, standard and control.
- 13. Do not mix various lot numbers of kit components within a test and do not use any component beyond the expiration date printed on the label.
- 14. Kit reagents must be regarded as hazardous waste and disposed of according to national regulations.

# LIMITATIONS

- 1. All the reagents within the kit are calibrated for the direct determination of DHEA-S in human serum. The kit is not calibrated for the determination of DHEA-S in saliva, plasma or other specimens of human or animal origin.
- 2. Do not use grossly hemolyzed, grossly lipemic, icteric or improperly stored serum.
- 3. Any samples or control sera containing azide or thimerosal are not compatible with this kit, as they may lead to false results.
- 4. Only Standard A may be used to dilute any high serum samples. The use of any other reagent may lead to false results.
- 5. The results obtained with this kit should never be used as the sole basis for a clinical diagnosis. For example, the occurrence of heterophilic antibodies in patients regularly exposed to animals or animal products has the potential of causing interferences in immunological tests. Consequently, the clinical

diagnosis should include all aspects of a patient's background including the frequency of exposure to animals/products if false results are suspected.

# SAFETY CAUTIONS AND WARNINGS

# POTENTIAL BIOHAZARDOUS MATERIAL

Human serum that may be used in the preparation of the standards and controls has been tested and found to be non-reactive for Hepatitis B surface antigen and has also been tested for the presence of antibodies to HCV and Human Immunodeficiency Virus (HIV) and found to be negative. No test method however, can offer complete assurance that HIV, HCV and Hepatitis B virus or any infectious agents are absent. The reagents should be considered a potential biohazard and handled with the same precautions as applied to any blood specimen.

#### CHEMICAL HAZARDS

Avoid contact with reagents containing TMB, hydrogen peroxide and sulfuric acid. If contacted with any of these reagents, wash with plenty of water. TMB is a suspected carcinogen.

#### SPECIMEN COLLECTION AND STORAGE

Approximately 0.1 ml of serum is required per duplicate determination. Collect 4 – 5 ml of blood into an appropriately labelled tube and allow it to clot. Centrifuge and carefully remove the serum layer. Store at 4 °C for up to 24 hours or at -10 °C or lower if the analyses are to be done at a later date. Consider all human specimens as possible biohazardous materials and take appropriate precautions when handling.

#### SPECIMEN PRETREATMENT

This assay is a direct system; no specimen pretreatment is necessary.

# ASSAY PROCEDURE

#### Specimen Pretreatment: None.

All reagents must reach room temperature before use. Standards, controls and specimen samples should be assayed in duplicate. Once the procedure has been started, all steps should be completed without interruption.

- Prepare working solutions of the DHEA-S-HRP conjugate and wash buffer.
   Remove the required number of well strips. Reseal the bag and return any unused strips to the refrigerator.
   Pipette 25 µl of each standard, control and specimen sample into correspondingly labeled wells in duplicate.
- **4. Pipette 200 μl** of the **conjugate working solution** into each well. (*We recommend using a multichannel pipette.*)
- 5. Incubate on a plate shaker (approximately 200 rpm) for 45 minutes at room temperature.
- 6. Wash the wells <u>3 times</u> with 300 µl of diluted wash buffer per well and tap the plate firmly against absorbent paper to ensure that it is dry. (*The use of a washer is recommended.*)
- **7.** Pipette **150** µl of **TMB substrate** into each well at timed intervals.
- 8. Incubate on a plate shaker for 15 20 minutes at room temperature
- (or until Standard A attains dark blue colour for desired OD).
- **9.** Pipette **50 µl** of **stopping solution** into each well at the same timed intervals as in step 7.
- **10.** Read the plate on a microplate reader at **450 nm** within 20 minutes after addition of the stopping solution.

# CALCULATIONS

- 1. Calculate the mean optical density of each standard duplicate.
- 2. Draw a standard curve on semi-log paper with the mean optical densities on the Y-axis and the standard concentrations on the X-axis. If immunoassay software is being used, a 4-parameter or 5-parameter curve is recommended.
- 3. Calculate the mean optical density of each unknown duplicate.
- 4. Read the values of the unknowns directly off the standard curve.
- 5. If a sample reads more than 10  $\mu$ g/ml then dilute it with Standard A at a dilution of no more than 1:8. The result obtained should be multiplied by the dilution factor.



#### **PERFORMANCE CHARACTERISTICS**

#### SENSITIVITY

The lower detection limit is calculated from the standard curve by determining the resulting concentration of the mean OD of Standard A (based on 10 replicate analyses) minus 2 SD. Therefore, the sensitivity of the DHEA-S ELISA kit is **0.005 \mug/ml**.

#### SPECIFICITY (CROSS REACTIVITY)

The following compounds were tested for cross-reactivity with the DHEA-S ELISA kit with DHEA-S cross-reacting at 100%.

Three samples were assayed ten times each on the same standard curve. The results (in  $\mu$ g/ml) are tabulated below:
